 1. 1 face shot (close up) in natural make-up with hair down.
 2. 1 full-length standing shot in cheer/dance uniform with hair down (no bow).

- MALE applicants should include:
 1. 1 face shot (close up), no facial hair.
 2. 1 full-length standing shot in uniform.
 3. 1 full-length standing shot in warm-up.

Photos MUST be digital and high quality. No cell phone or social media photos will be accepted. Photographs must be taken within the last 60 days and feature the applicant's most current hair length and color. Applicants may be contacted for additional images.

Please do not contact The U.S. Finals office for information regarding The U.S. Finals model search. **The U.S. Finals will contact finalists only by March 13, 2019 via email to the athlete and to the parent/guardian listed on this application.** If you do not receive an email from us by March 13, 2019, this indicates that you were not selected as a winner. Photo shoots will be held in Atlanta, GA or in Louisville, KY. The winning model (and one (1) parent or guardian if the winner is a minor) will receive round trip, coach air fare transportation between the photo shoot location and the nearest major airport to the winner's residence with accommodations, transportation, and meals paid by U.S. Finals.
